New Security Rules of Behavior Required for TRACS Transmissions Effective April 30, 2010

Everyone who submits TRACS files via iMAX will be required to complete a Security Awareness Training and accept Rules of Behavior annually. **This change will become effective on April 30, 2010. It must be completed by no later than August 31, 2010 for all current users.** The automated Rules of Behavior (ROB) will be administered like the EIV online security exam.

What do you have to do?

- o Complete the Security Awareness Test and accept the Rules of Behavior
- o Update your TRACS User iMAX User Profile by August 31, 2010
- o If you DO NOT complete this process by August 31, 2010, you will be unable to successfully transmit your TRACS files. You will receive a 401 Error, which will tell you that you need to complete the Security Awareness Training and accept the Rules of Behavior before transmitting through TRACS.

Watch for TRACS System Rules of Behavior in September. More about that in future Practical Points.

New EIV Glitches...

Due to technical problems, Income Reports by Recertification Month, Income Discrepancy, New Hires, Identity Verification, Deceased Tenants, and Multiple Subsidy Reports will **not be available between April 19, 2010 and April 26, 2010**. You *will* be able to access individual income reports during this time.

Tenants with **last names longer than 19 characters cannot be verified in EIV** at this time. Programmers are working with the Social Security Administration on a fix. At this time, the SSA only does a 19-character verification match. You will see Tenant Income Reports that say "Income Cannot be Displayed as the Tenant Identity has not been Verified", and the tenant will not show up on either of the Failed Verification Reports.

EIV Version 9.1... Coming on April 19, 2010

EIV is scheduled to be updated twice a year, in April and September. However, due to budget constraints, the September release will just be a fix/maintenance update. New developments in the April version include:

- o Tenant Income Reports will have the unit code and unit address
- o Statistics have been removed from the Identity Verification Report
- o EIV Security Test: Beginning 30 days before the anniversary date of your last security test, when you log in, the test will pop up automatically. Be sure to pass it within 30 days to avoid losing EIV access!

- If you do not pass, the correct answers will no longer be viewable from your screen. However you will be able to see the links to find them.
- Find the right answers and re-take the test until you pass it, in order to retain your access to EIV data
- o Multiple Subsidy Report: You'll be able to search by Social Security Number
- o A new search capability (by SSN) has been added to the Multiple Subsidy Summary page.
- o The New Hires Report is set to cover a six-month period.

New SAVE User? Request Access by April 15, 2010

If you already received your new SAVE User ID and Password since June 2009, there's nothing for you to do. If your site needs to register new SAVE users, though, they need to apply quickly!

The SAVE (Systematic Alien Verification for Entitlements) system is required to verify immigration documents provided by Eligible Non-Citizens under age 62.

TIPS

<u>Question:</u> We want to switch from the corporate office transmitting TRACS for all the sites to our site managers submitting their own. How do they obtain access to iMAX? They all have WASS IDs for EIV – is it a matter of making those IDs able to be used, or do we have to get new IDs through another means? **Holly, SC**

Answer: The first question, Holly, is, does each site have its own TRACSMail ID (otherwise known as iMAX ID), or is the home office transmitting all sites under the same ID? In order to have each manager transmit his/her own data and get responses properly, each site will need its very own iMAX ID (formerly known as a TRACS Mailbox Number). If you need to get a TRACSMail ID for particular properties that don't have their own, the form for that is at: http://www.hud.gov/utilities/intercept.cfm?/offices/hsg/mfh/trx/pdf/tracsmailid.pdf.

The TRACSMail ID belongs to a property or group of properties. The WASS ID belongs to a person. In order to transmit to iMAX, there are two separate authentications. First, the person must sign in with his/her WASS ID and password. Then, the secured transmission is made for a particular site/site set, using its TRACSMail ID. Each manager will need the WASS Coordinator (with iMAX COR authorization in User Maintenance) to assign him/her the IME role before s/he can transmit files through iMAX.

Question: I'm having a hard time figuring out why EIV Discrepancy Reports show income higher than what we verified for the 50059. What are the possible reasons for this? **Paul, IA**

<u>Answer:</u> Paul, I'm glad you asked! First, bear in mind that Discrepancy Reports only show total amounts. When the total annualized figure is \$2400 or more over the total wage + benefit amount on the last 50059, the amount will be added into the discrepancy total.

Start with the tenant file. Some income is excluded from 50059 calculations, but will show up in EIV. For example, the income of a Full-Time Dependent Student who earns \$10,000/year will only show as \$480 on the cert. Sometimes an income code on the 50059 was incorrect. For example, if SSI income is incorrectly listed as a Pension on the 50059, you'll see that amount in the Discrepancy Report, because the cert showed no SI income.
