#### **EIV Has Been Unavailable**

HUD had announced that, due to technical problems, EIV would not be available between April 19 and April 26. However, the system continued to be down throughout the rest of April and into May.

HUD will let us all know when EIV is not available – and when it will be back up – though the RHIIP Listserv, which is available free and comes via email.

So what do you do about HUD's requirement to use EIV Income and Income Discrepancy Reports for all recerts? The Listserv's Revised Message #219 instructs sites to proceed with recerts, and do third party verifications. It also suggests that sites document tenant files that are missing EIV data due to the system being down. Acceptable documentation includes a copy of the RHIIP Listserv message in the tenant file. # **REAC Tightens Up TRACS Security**

**Special Notice:** On May 1, 2010, REAC posted a notice that the release of the automated Rules of Behavior has been delayed. They do not expect the delay to last more than 7 days. An announcement will be posted when the release date has been confirmed.

The next time you log into TRACS and/or iMAX on HUD's Secure Systems, you're going to be presented with some new items you haven't seen before. HUD is implementing a TRACS Rules of Behavior (ROB) and TRACS Security Awareness Training Questionnaire (SATQ) for TRACS Coordinators and Users. Their goal is to protect tenant information by implementing maximum security.

<sup>\*</sup>For those transmitting TRACS files through on-site software - if you have not accepted the ROB by September 3, 2010, you will no longer be able to transmit TRACS files from your software.

#### **Please Note:**

- If you have already accepted the Rules of Behavior in iMAX, you will not need to in TRACS.
- The ROB and SATQ will need to be completed once a year.

# **HUD Ideas in Action – Your Voice Will Be Heard!**

HUD Ideas in Action is a website designed for members of the housing community (as well as HUD employees) to chime in and/or vote on ideas submitted by other readers. These ideas correspond with the specific categories HUD has posted on the website. There are a total of 7 categories, 4 of which are brand new! Your creative ideas are strongly encouraged, and may even be accepted for a closer look by HUD reviewers!

#### What are these categories?! How do I post an idea? What does it mean to vote on an idea?

Recently, HUD wanted feedback from readers on their FY 2010-2015 Strategic Plan. According to the website, the Strategic Plan is an outline of what they can do to strengthen their relationship with you, your residents, as well as HUD employees and industry partners, over the next 5 years. Readers were able to post their ideas on what they would like to see added to the Strategic Plan. Once an idea is posted, other readers can vote on it if they feel strongly about what the poster has said.

Though HUD action is not guaranteed on every suggestion, we *are* seeing results! Here is an example of an idea that was posted by a reader, voted on by other readers, then reviewed and responded to by HUD: the reader contributed the idea that HUD should provide funding for affordable housing or a "cohousing community" where residents with large families can live together under one roof. He/she then elaborated to say that the support of family is crucial to the wellness of individuals and often overlooked, as families are usually separated from one another. HUD responded by providing information the reader could review and see that HUD has experimented with the cohousing model. They mentioned that HUD programs already exist that provide community support services and other helpful programs for tenants. Lastly, they requested more detailed information from the reader on how this program would operate and where it would be most helpful.

# **Your Contract Administrator (CA) May Change**

Several years ago, HUD subcontracted out the administration of all Section 8 programs. Contract Administrators can be Housing Authorities, State Housing Finance Agencies or private companies partnering with HAs or HFAs. HUD continues to administer all non-Section 8 programs.

There are two types of CAs: Traditional (TCA) and Performance-Based (PBCA). The first PBCA contract began in 2000. Now, HUD is putting all of the PBCA contracts up for re-bid in 2011. HUD will be asking for responses to an RFP (Request for Proposals), and Contract Administrators may be bidding on multiple states.

Watch for more information as the process moves forward.
