On February 23, 2016, the Department posted an updated version of Chapter 9 of the Section 8 Renewal Policy Guide to the Department’s Multifamily Housing Drafting Table. The Department will receive feedback on the draft through March 25, 2016. The new draft has been substantially reorganized, but contains few changes in departmental policy. Revisions include: organizing the material for each stakeholder group, requiring stronger narratives, updating the Sample RCS, and revised reviewer checklists.
